"DLT in the Real World" Findings

The survey, supported by Accenture, Broadridge and VMware and - as last year - managed by the ValueExchange, has reached across the entire industry to provide uniquely comprehensive industry benchmarks around how we are planning, progressing and realizing our DLT ambitions in the real world. This campaign was designed to provide you with unique, actionable insights on how DLT is being used across the world, giving you the chance to learn from your customers and your peers where DLT is solving real world problems, where it is not and how people are making the most of this technology. This is the third iteration of the survey and so this allows insights into changes over time and it starts to show in the evolution of our industry and of DLT. The ValueExchange's "Key Findings" document can be found here giving you an early view of the headline conclusions in this research and ISSA is presently producing a podcast for the results which should be published shortly.

The DLT Working Group is partnering with GBBC/GDF to create a Crypto Custody paper as its next ambition.

ISO 20022 Update

The Working Groups are always challenging the ISSA team to think differently and this has led to the launch of the first <u>external resource centre</u>. The Working Group has collected a number of papers which were used to inform the WG Members for the debates. These are all necessarily useful papers that now are collated into the Resource Centre. The aim is to provide a destination that Members can utilize to (a) inform themselves and their organizations and (b) add to as they find useful documents. Please send such documents to colin.parry.issa@sixgroup.com for loading into the site as you find and use them.

The API group has also collated the views of the members of both the ISO 20022 WG but also the Asset Servicing Group to create a paper setting out the benefits for the industry from adopting a more standardized approach to APIs and from leveraging the ISO 20022 standard above other potential standards and/or data models. The paper will be published before SIBOS.

Withholding Tax Processes Paper

In August, the Asset Servicing Working Group (WG) published a paper entitled <u>'Withholding Tax Processes - Identifying the Key Challenges and Potential Solutions to Withholding Tax Relief and Recovery Processes'</u>.

The paper was the result of the WG's review of current WHT processes. After identifying the key challenges faced by Securities Services providers when handling WHT processes, and the impact of these challenges on the various parties, the WG then focusses on the potential solutions and recommendations for change.
