# **Introductions and Welcome**

#### Introduction

### Status Update on Phase I

#### Introduction

Flora provided a summary of the work that has been ongoing regarding two components of the first Phase I: Education and Level Set.

#### **Key Points Addressed**

Work on two of the Phase I sub-streams has almost been completed. This first phase is critical as a scene setting and a foundation for the second phase which will focus on the challenges of ESG in Securities Services and an assessment of the existing services and solutions.

Flora then provided a summary on the two sub-streams:

- ESG Glossary
- Resource Centre

#### **ESG Glossary**

This sub-stream aimed to provide an explanation of ESG concepts through the creation of an ESG Glossary for Securities Services. The sub-stream has now completed the glossary and it is currently being reviewed and formatted.

### **Resource Centre**

The WG participants in this sub-stream focused on providing a resource centre for non-ISSA collateral. They have identified which documents should be included in the resource centre and the information is currently being loaded on to the ISSA website.

Flora asked for feedback from the WG participants on their view on the sub-stream effort. Peter and Juliette both felt the experience was positive and that they had learned more about the topics from being actively involved. All attendees confirmed the value of the effort and that it would achieve its objective of helping to bring both members, and the broader industry, to a good basic level of understanding of ESG concepts.



## **Next Steps**

### Introduction

Flora and Karen then outlined the planned next steps.

### **Key Points Addressed**

Flora summarized the next steps and delivery timeframes for each of the two current sub-stream work. These include:

#### **ESG Glossary**

The objective is to sign off the glossary in the coming weeks with publication on the ISSA website and social media by end November.

#### Resource Centre

Again, the resource centre is scheduled for completion shortly. Publication will be included on the ISSA website and social media at the same time as the ESG Glossary.

Flora and Karen then outlined the focus for the next topics.

#### **ESG Framework**

The ESG Framework will look at the investment lifecycle data flows, specifically focusing on those areas where Securities Services is involved. The initial call will focus on agreeing the scope of the work and understanding whether due diligence should be a component. This sub-stream will be led by Hai Jade.

The first call for this sub-stream will be scheduled for either December or early next year.

## **ESG Impact Opportunities and Problem Statement**

The second Phase will then commence. The scope of this effort will be to understand the impact opportunities and problem statement.

The first call for this sub-stream will be scheduled early in 2024.
