#### **Future of Securities Services**

In 2020, ISSA published the "Future of Securities Services". The paper outlined a set of key forces and strategic themes expected to impact the Securities Services industry over the subsequent five to ten years, to allow industry leaders to take informed actions and to foster collaboration among ISSA members to solve industry-level problems.

Ten important trends, forces, were identified in Capital Markets/Securities Services in the paper ans concluded that changes in investor behaviour, as well as changes in technology and technology-enabled competition, were likely to have the biggest impact on the industry.

The Working Group (WG) was reconvened last year to review the paper. Its task was to verify whether – or not – the hypothesis were confirmed, still unproven or disproved and to forecast the future impact of key forces on the direction of the industry.

In addition, the WG was asked to include any additional forces that it felt were significant for the industry and to detail why. That work is now complete and will be presented shortly in the revised paper, adding an eleventh trend/force – Accelerated Settlement, as well as a third composite force - Geopolitics. Also included are videos of senior leaders from ISSA member firms, speaking on topics covered in the paper.

The output both validates, and feeds into, the ISSA agenda for 2024 and onwards. The ISSA Board, along with the CEO Office, continues to actively manage ISSA's priorities and, as can be seen in the paper's concluding section, ensures that the strategic themes identified for the industry match the core ISSA agenda.

#### **Digital Identity & Onboarding Challenges**

Have you ever wondered why it takes so long to onboard an institutional investor? The answer is because it is hard:

"Onboarding is a complex process requiring multiple documents to be exchanged and validated. The legal and regulatory rules can vary between country and domiciles of both the institution onboarding and being onboarded. The requirements need to encompass many different objectives from Know-Your-Customer (KYC) and Anti-Money Laundering (AML) legislation to tax documentation, system access and cyber security. In addition, there are product, credit and country specific dimensions to onboarding."

This <u>paper</u> explains the challenges and sets the scene for the WG to explore the solutions to making onboarding a better experience for clients and the industry.

#### **New Working Group - Evolving Technologies**

The Evolving Technologies WG will commerce in the fourth quarter of 2024.

The WG's focus will be to look at solutions for evolving technologies that could be used by the Securities Services industry. To ensure that there is no duplication on effort, the Digitization and DLT WGs will close and the new WG will incorporate these themes. Additionally the new WG will focus on three new streams:

- Digital transformation
- Value transformation
- Client experience

#### **New Working Group - Investor Solutions**

The Investor Solutions WG will commerce in early 2025.

There is a clear interconnectedness between investors - such as asset managers and corporates - and Securities Services providers. Investors need to provide their Securities Services providers with transactional information, and, in return, Securities Services providers provide data and report to their investor clients. However, this daily exchange of information is often fraught with issues for many investors who face multiple ongoing challenges. The Investor Solutions WG will therefore focus on better understanding the challenges faced by investors where they intersect with Securities Services providers and consider what possible options are available to help mitigate these issues.

#### **New Working Group - Out of Network Assets**

The Out of Network Assets WG will commerce in the fourth guarter of 2024

In 2014, ISSA published a paper on out of network assets in conjunction with the Association of Global Custodians (ACG). The new WG will look to update the current challenges in providing safekeeping and supervisory services for out-ot-network assets and revise its previously published legal and practice framework. The aim will be to enhance informational transparency of the legal and practice context for these assets, enable more effective management of the risks associated with these assets, and increase operational efficiencies among market participants in servicing these assets.
