## Introductions and Welcome

#### Introduction

#### **Key Points Addressed**

Hai Jade firstly thanked all of those who had contributed so far.

She then shared the latest version of the data flows document and highlighted the following:

- An introduction has been added to the document to provide context
- The base model showing where there are ESG data flows that connect to Securities Services (both inflows and outflows) and the four areas of focus have now been completed
- The key topics have been identified and one-pagers have been collated which reflect the more detailed information (names are currently included so that attendees can see the collaboration to date)

#### **Key Points Addressed**
