- The Vice Chair of the Operating Committee will be announced shortly



Julie has a Bachelor of Business Studies (Finance) from Massey University, New Zealand.







 - Our entire membership is welcome and encouraged to join










CEO Office Update - Membership Regional Update

ISSA Hot Topics – New Working Groups

Cyber WG

- Status
 - ISSA originally created a Cyber WG in 2017
 - A paper on Cyber was published in 2018 and then a set of use cases in 2020
 - The WG will now be re-opened and the previous report updated, focusing particularly on new Cyber threats and the implications and mitigants
- WG participation
 - The WG will commence in Q4 2025
 - WG participants will be required who have the specific Cyber experience and expertise (CISO or deputy)

Uncertainty* WG

- Status
 - A new WG will be created to look at:
 - Themes that are topical and of key interest to the membership
 - Themes where review is needed to understand if a topic requires an ISSA WG
- WG participation
 - The WG will commence in Q1 2026
 - Looking at short timeframe for deliverables within 3-6 months
 - Each theme will require participation from different attendees and Co-Chairs

Evolving Technologies WG

- Status
 - The Evolving Technologies WG currently encompasses multiple technological themes, including digital assets
- Digital Assets WG
 - It has been decided to form a separate
 Digital Assets WG moving forward
 - The focus of this WG will be on market, regulatory and operations requirements as well as technology
 - The WG will change in Q4 2025
- Evolving Technologies and AI WG
 - In future, the Evolving Technologies WG will focus on new and emerging technologies such as Cloud and AI



ISSA Working Groups – Updated Structure






















