Working Group Update

Accelerated Settlement - T+1 in the EU & UK

The key results of ISSA's latest "Accelerated Settlements: T+1 in the EU & UK" Pulse Survey, provides a clear picture of how the EU and UK are progressing toward accelerated settlement. Our research was conducted in collaboration with the Value Exchange and in partnership with T+1 Accelerated Settlement Taskforce, DTCC, Euroclear and Clearstream, and backed by other leading industry associations EFAMA, ISITC, ASIFMA, IA, ECSDA and EBF.

66% of the industry is now in project mode for T+1 in the UK, and 65% of firms are engaged on T+1 in the EU. Much more information on firms' preparations is available in the report. The Key Findings Report can be accessed <u>here</u>.



Asset Servicing WG - White Paper

The ISSA Asset Services WG, in partnership with The Value Exchange, has performed survey research on the potential to enhance the efficiency, speed and accuracy of corporate action announcements and address issues in corporate governance, specifically in proxy voting and class actions. This research has highlighted the existing gaps in communication and operational efficiency as well as the importance of collaboration among key stakeholders to resolve the issues that cause delays in disseminating fully accurate information between issuers and their investors.

Such collaboration could lead to designing global principles and standards to guide national markets in implementing automated solutions for digitized event announcement data created "At Source". This could lead to a significant increase in the speed and quality of the two-way flow of information and transactions between issuers and investors, maximizing the effectiveness and efficiency of corporate governance. DI&O WG - Solutions Paper

The Digital Identity and Onboarding WG has just completed its second <u>paper</u> which addresses the challenges of client onboarding and digital identification. This paper is supplemented with a <u>video</u> of some of the team from the Digital Identity and Onboarding WG.

The paper urges Securities Service Providers to promptly tackle the issues within their control to enhance client service and accelerate revenue generation. For challenges outside their control, the WG identifies who needs to be involved and what support is required, stressing that progress depends on collective commitment to change. The aim of this paper is to spark action across the industry.
